Follow the instructions below to customize your newsletter emails.

- 1) Log into your Bloomberg Law subscription with your username and password at www.bloomberglaw.com. If you forgot your password, you can reset it here: <https://profile.bna.com/profile/forgotpw>
- 2) Once logged in, access the relevant news channel from the corresponding practice center or clicking the > icon in the top left corner of the Bloomberg Law News page: <https://www.bloomberglaw.com/bloomberglawnews/>
- 3) From the news page on your Bloomberg Law product, select **Manage Subscription** as highlighted in the image below.

To receive emails on just the News stories, Insights written by attorney-practitioners, or summaries of Latest Decisions, check the appropriate box. Optionally, tailor the email further to view relevant content by selecting a topic(s). Additional filters may be available and vary depending on the newsletter subscription selected. Select a day and time you wish to receive the email and click **Save**.

Note: The *Latest Decisions* feature is available on Labor & Employment, Intellectual Property, and Benefits & Executive Compensation news channels. A similar feature, *Tax Developments*, is available on Tax and Benefits & Executive Compensation channels.
